This **limited warranty** covers defects in **materials and/or workmanship** only. Diamond Manufacturing will repair or replace any parts which are found to be defective in materials or workmanship for a period of <u>six (6) months</u> from the date of shipment or invoice. The defect must occur during normal use of the product within the warranty period. SHANKS ARE EXPRESSLY EXCLUDED FROM THIS LIMITED WARRANTY AND ARE SPECIFICALLY ADDRESSED BELOW.

With regard to SHANKS only, Diamond Manufacturing will repair or replace shanks against breakage for **thirty (30) days** from the date of shipment. The breakage must occur during normal use of the product within the warranty period. However, **RIPPER SHANKS** are NOT warranted if:

- The shanks are welded or cut on.
- The shanks are used in a manner that is inconsistent with their design (i.e., pulled behind a tractor larger than for what they were designed)
- Any circumstances deemed unusual or uncommon use by Diamond Attachments.

This limited warranty outlines specific legal rights. Diamond Manufacturing does not authorize any person to create any obligation or liability other than stated in this Limited Warranty.

NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY AND/OR FITNESS FOR A PARTICULAR PURPOSE SHALL BE APPLICABLE TO ANY PRODUCT SOLD BY DIAMOND MANUFACTURING. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF.

DIAMOND MANUFACTURING EXPRESSLY DISCLAIMS LIABILITY FOR ANY SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES, LOSS OF TIME OR PROFITS, DIRECT, INDIRECT, OR GENERAL DAMAGES ARISING OUT OF ANY BREACH OF WARRANTY, EXPRESS OR IMPLIED.

#### **Conditions of Warranty**

It is the customer's responsibility to give Diamond Manufacturing notice of any warranty claim as soon as possible. You must contact Diamond Manufacturing or an authorized dealer immediately so that repairs can be made in a timely manner. It is the customer's responsibility to maintain the equipment in accordance with the instructions provided by Diamond Manufacturing. It is recommended that you keep records and receipts as you may be asked to prove that the maintenance instructions have been followed.

It is also your responsibility to operate the equipment in a safe manner, and for the use for which the equipment was designed. If a defect in materials or workmanship occurs, it is your responsibility to cease operating the equipment until proper repairs are made. **Damage which occurs from continued operation is not covered by this warranty. Failure to comply with these conditions may invalidate this Limited Warranty.** 

#### This Warranty Does Not Cover Damages Caused By:

- Abusive operation
- Misuse or neglect
- Natural calamities or accidents
- Unauthorized modifications or repairs
- Neglected maintenance
- Unapproved attachments
- Usage contrary to the intended purpose
- Damage caused by installation of the air conditioning system by anyone other than Diamond Manufacturing or a technician authorized by it. (This does not apply to a defect in materials of any component part of the air conditioning system manufactured by Diamond Manufacturing)

#### This Warranty Does Not Cover:

- Pickup or Delivery of the equipment or product
- Installation or other labor charges (including the Air Conditioner)
- Rental of replacement equipment during the repair period
- Freight charges for replacement parts
- Travel time or mileage
- Component parts that are not manufactured by Diamond Attachments

### **How to Obtain Warranty Service**

To obtain warranty service under the terms and conditions of this Limited Warranty, you must deliver the product to Diamond Manufacturing, PO Box 270, Atoka, OK 74525 (transportation and insurance prepaid) or to an authorized Diamond Manufacturing Dealer, within the warranty period, along with proof of purchase. Failure to notify Diamond Manufacturing of any potential warranty claim prior to having the damage repaired waives the protection provided by the Limited Warranty and relieves Diamond Manufacturing of any obligation under the Limited Warranty. The Limited Warranty is not effective if the damage is repaired by anyone other than Diamond Manufacturing or its authorized dealer.

#### **Governing Law**

Any and all actions arising out of the sale of this product, including any warranty claim, shall be governed by and construed in accordance with the laws of the State of Oklahoma and the applicable law of the United States of America without regard to conflict of law principles. Any action or proceeding in connection with this product, including any warranty claim, shall only be brought in the District Court of Atoka County, Oklahoma.
